Awarded to an attorney who has made an outstanding contribution to promoting minorities in the legal profession and community.

SCREENING AND SELECTION CRITERIA

- Any Oregon licensed attorney, except a member of the OWLS Board of Directors or of the Roberts-Deiz Awards Dinner Committee, is eligible to receive this award. Former nominees (but not award recipients) may be re-nominated.
- The recipient must have made an outstanding contribution to promoting minorities within the legal profession and community.
- The award is intended to recognize and honor personal and professional conduct that promotes minorities in the legal profession and community. While the committee considers leadership activities and service, activities or conduct that evidence a nominee's efforts towards promoting minorities will be more probative to the committee.
- Because the award recipient should serve as a role model, an appreciation of diversity in the nomination and selection processes is important. OWLS recognizes the important contributions of all lawyers: women and men, those in public service and government, in-house corporate and private practice, solo and large firm practitioners, minorities, trial lawyers, and non-litigators.
